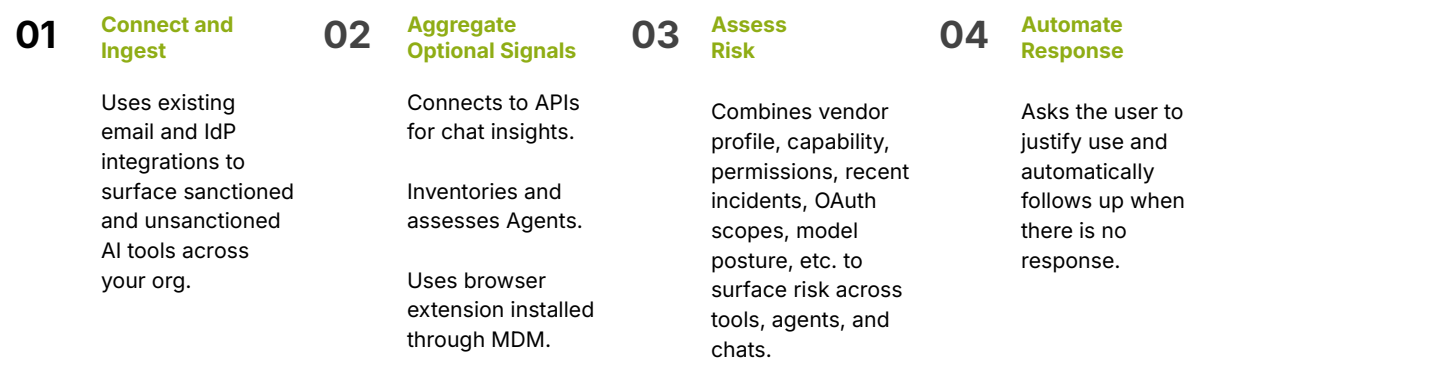

How It Works

Shadow AI shows up in email and sign-in activity before it shows up anywhere else. AI Governance starts there, then layers in chat, agent, and browser signals to turn that activity into risk you can act on, not just log.



What You Need to Connect

Visibility starts with your existing email and identity stack. Every additional connection narrows the blind spot further, on your timeline.

Integration	Required	Why is it required
Email API (Microsoft 365/Google Workspace)	Required	Surfaces new AI tools the moment someone signs up.
Identity Provider (Entra/Okta)	Required	Supplies sign-in events and OAuth permission data.
Chat Providers (ChatGPT, Claude, Copilot, Gemini - Enterprise Plans)	Optional	Enables Chat Insights, which flags sensitive information shared in AI chat conversations.
Agent Infrastructure (Amazon Bedrock, Google Gemini Enterprise, Azure AI Foundry, Copilot Studio, Glean)	Optional	Enables AI agent discovery, ownership, and permission mapping on each connected platform.
Browser extension (Chromium-based)	Optional	Deployed through your MDM. Catches personal-account use, in-browser AI, and on-device chat analysis.

Connecting your identity provider and email gets you most of the picture on day one. Every other connection adds depth.
